You and each of you are hereby notified that I have called a special meeting of the Board of Mayor and Aldermen of the Town of Monterey, Tennessee, to be held on Tuesday, May 19, 2020 at 7:00 p.m. in a special called conference session for the purpose of:

1. 2nd Reading of Ordinance #20-839 – An Ordinance to amend Title 18 of the Monterey city code regarding water and sewer rates
2. 2nd Reading of Ordinance #20-840 – An Ordinance of the Board of Mayor and Aldermen of the Town of Monterey, Tennessee, to provide a tax levy for the Town of Monterey, Tennessee for the fiscal year ending 2021
3. 2nd Reading of Ordinance #20-841 – An Ordinance of the Town of Monterey, Tennessee, adopting a budget for the fiscal year July 1, 2020 through June 30, 2021
4. Consider bids for the Connectivity Grant

Item 1. Nathan Walker made a motion and was seconded by Starlett Wessels to pass the 2nd Reading of Ordinance #20-839. JJ Reels made a motion and was seconded by Alex Garcia to amend this ordinance by deleting item g (the \$2 administrative fee) off of this ordinance. After a roll call vote on the amendment, all present voted yes. Motion carried. After a roll call vote on the original motion, all present voted yes. Motion carried.

Item 2. Nathan Walker made a motion and was seconded by Alex Garcia to pass the 2nd Reading of Ordinance #20-840. After a roll call vote, all present voted yes. Motion carried.

Item 3. Nathan Walker made a motion and was seconded by Alex Garcia to pass the 2nd Reading of Ordinance #20-841. After a roll call vote, all present voted yes. Motion carried.

Item 4. JJ Reels made a motion and was seconded by Alex Garcia to accept the low bid of \$163,830 from Stubbs Construction. Mayor Wiggins pointed out that this connectivity from Burks Elementary School to the current walk way by the railroad has been in the works since 2015. After a roll call vote, all present voted yes. Motion carried.
